Subject:- Centrally Sponsored Scheme on Mission for Integrated Development of Horticulture (MIDH) [National Horticulture Mission (Restructured)] - release of 3rd installment of funds (**General Category**) to **Haryana** Government during 2015-16.

Sir,

I am directed to refer to this Department's letter No. 18-25/2015-MIDH (NHM) dated 12.05.2015 about the administrative approval for implementation of the Centrally Sponsored Scheme on Mission for Integrated Development of Horticulture (MIDH) [National Horticulture Mission (Restructured)] under Krishonnati Yojna-State Plan and to convey the sanction of the President of India to the payment of an amount of ₹ **5,00,00,000/- (Rupees Five Crore only)** to Government of **Haryana** during 2015-16, for implementation of the Scheme in **Haryana**.

2. This assistance under the scheme is in the ratio of 60:40 by Central Government and State Government respectively.

3. In accordance with the revised procedure, the Reserve Bank of India may please be advised for debiting to the Account of the Department of Agriculture & Cooperation and passing on the credit to the Central Account Section, Nagpur, for transfer to the State Government of **Haryana**.

4. The said Grants-in-aid will be subject to the following conditions: -

(a) The grants shall be utilized and disbursed by the concerned implementing agency in accordance with the MIDH Operational Guidelines, Annual Action Plan (NHM)/Administrative Approval for the year 2015-16 and in accordance with the conditions stipulated in this letter.

(b) The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of audited accounts and Utilization Certificates to this Department as soon as possible after the close of the financial year.

(c) The audited records of all aspects (permanent or semi permanent) acquired wholly or substantially out of the grant to the implementing agency should be maintained as prescribed in General Financial Rule 2005 and shall be furnished to the Government of India annually by the end of June, following the financial year to which it relates.
