3. The payment of ₹1.00 crore (Rupees One crore only) shall be transferred through Demand Draft/RTGS to Small Farmers' Agribusiness Consortium (SFAC), New Delhi, who will submit the utilization certificate in the prescribed format (GFR - 12 A).

4. The grants shall be utilized and disbursed by the concerned implementing agency in accordance with the conditions stipulated in OM No. 18-61/2014-NHM dated 18<sup>th</sup> November 2014 (copy enclosed).

5. The accounts of all grantee Institutions or Organization shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and a provision to this effect should invariably be incorporated in all orders sanctioning grants-in-aid.

6. The implementing agency shall maintain proper accounts of the expenditure incurred and submit the statement of audited accounts and Utilization Certificates to this Department as soon as possible after the close of the financial year.
7. The audited records of all aspects (permanent or semi permanent) acquired wholly or substantially out of the grant to the implementing agency should be maintained as prescribed in General Financial Rule 2017 and shall be furnished to the Government of India annually by the end of June, following the financial year to which it relates.
8. Assets permanent or semi-permanent acquired wholly or substantially out of the grant by the Government of India shall not, without prior approval of the Government of India, be disposed of, encumbered or utilized for the purpose other than those for which the grant is being sanctioned.
9. The Implementing Agencies will follow other terms and conditions contained in the General Financial Rules 2017, as amended from time to time.
10. The project monitoring committee shall monitor the project at regular interval and furnish the progress report to this Department.
11. This sanction issues with the approval of Integrated Finance Division vide their Dy. No. 3536-FTS/AS & FA dated 11/10/2017.
12. This has been noted at Serial No. 11 of the Register of Grants of 2017-18 (as per GFR 235(A)).


